5. Fire-fighting measures

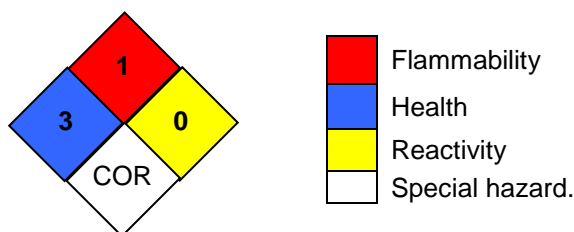
